About the Position

Dog walkers provide dogs within the shelter stimulation and exercise, which is crucial for the dogs' physical and mental wellbeing. We house up to 50 dogs and puppies at any given time, with the majority of the dogs coming in through our Inspectorate, arriving as strays, surrenders, emergency boarding and Inspector seized.

Key Duties

- Walking and supporting the training program with dogs on designated paths around the RSPCA shelter
- Spending some off-lead time in the exercise yards with toys playing games, socialising and training
- Spending time in the kennels with the dogs with general socialisation

Skills & Qualities

- Experience with dogs; experience with medium-large sized breeds would be an advantage
- The ability to safely handle large, strong, boisterous dogs
- Willingness to take direction
- A fitness level that allows for two hours of walking, including over uneven terrain
- Positive and upbeat attitude
